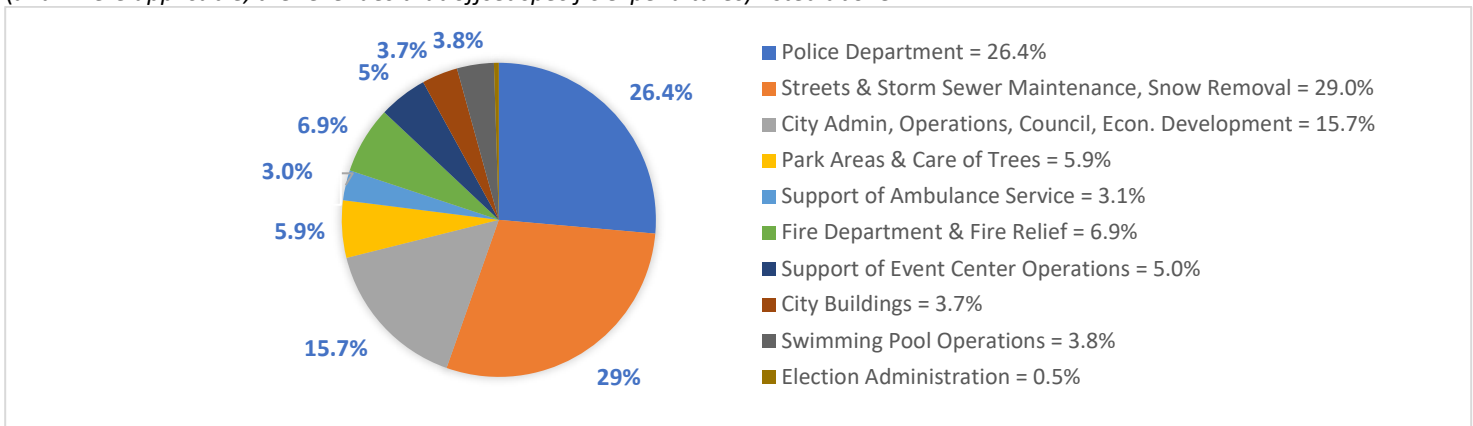

Dear City of Parkers Prairie Community Member,

Today we find ourselves in a challenging economic environment. Anyone who buys goods or services knows that costs are on the rise, and all too often a family's income fails to keep up with the pace of inflation. We are experiencing the same challenges at the City level. Costs for equipment, operating supplies, and services have risen at a tremendous pace. Meanwhile, our City has roads that need repair, aging utility infrastructure that needs replacement, parks and City buildings that need to be maintained, and vital services that need to remain available in our community. It is difficult to prioritize what to spend the taxpayer's hard-earned dollars on when *each* of those things listed above is of priority to *someone*.

Your elected City Council members, City Staff, and I have taken the time to consider the many needs of our community when preparing the City budgets – what items deserve top priority, how to best utilize tax dollars, and in what areas we can cut spending. Your elected officials took an oath to represent the citizens of Parkers Prairie and to make decisions that may best serve the *whole* community, even when some of those decisions are very difficult to make.

Due to inflation and funding challenges in the past few years, we had postponed the next street and utility improvement project. With so much of our infrastructure in need of replacement, more delay only puts us further behind the improvement schedule. We are now in the planning stage for the next project, which is preliminarily scheduled for construction this coming summer (2024). The focus is on two streets with the oldest infrastructure and worst asphalt condition: Sunset Avenue and East Lake Street. Additionally, the main sanitary sewer lift station (on the north side of Lake Adley) is in dire need of replacement and will be relocated to a slightly higher elevation to safeguard against the rising water level of Lake Adley that we have seen in recent years. You will soon see engineers surveying these areas to prepare for the project. Once the bids come in for the project, we will determine if there will be adequate funding to proceed.

How will the 2024 project be funded? Some parts of the project, like the street portions without underlying water and sewer infrastructure, will be funded with general fund tax levy dollars. Street portions where underground water and sewer utilities will be replaced will be funded with our City water and sewer revenues. While none of us like to see increases in water and sewer rates, the changes are necessary to provide us with adequate revenue to bond for this project, for which payments would be made over a period of 20 years. We do *not* plan to use special assessments to fund this project. Federal grants are only available *after* we have met a certain threshold for monthly utility rates (which is based on our City's median household income). Even after the January 1, 2024 rate increases, we are still nowhere near meeting this threshold. As always, we will continue to look for funding alternatives to help alleviate the burden on our community members.

The information on the opposite side of this letter is a summary of the revenue and expenditure budgets for the departments supported by the City's General Fund. The 2024 budgets and tax levy were finalized in December of 2024. You will notice that some of the items in the expenditure budget on the left are supported (or offset) by revenues listed on the right.

Each year, at the beginning of the regular City Council meeting in December, there is time set aside for the members of the public to speak to the Council regarding the City's proposed budget and tax levy for the upcoming year. *This public hearing is called the Truth in Taxation Public Meeting, and it takes place *prior* to the Council adopting the upcoming year's budget and tax levy. The Truth in Taxation Public Meeting in 2023 took place on Monday, December 18th, at 7:00 pm at the Parkers Prairie City Hall. Please feel free to contact me at the City Hall if you have questions about public hearings, the tax levy, or the City budgets. My office phone number, address, and email are listed below.

**Please note that the Truth in Taxation Public Meeting is NOT the meeting where you may discuss the valuation or classification of your property. Those items are addressed at the Local Board of Appeal & Equalization meeting, which takes place in April.*

On behalf of your elected officials, and myself, I want to say that we welcome your comments, feedback, questions, and ideas. We want you to understand that we care about the same issues that are important to *you*. Know that we are listening when you tell us about your priorities and your visions for our community.
